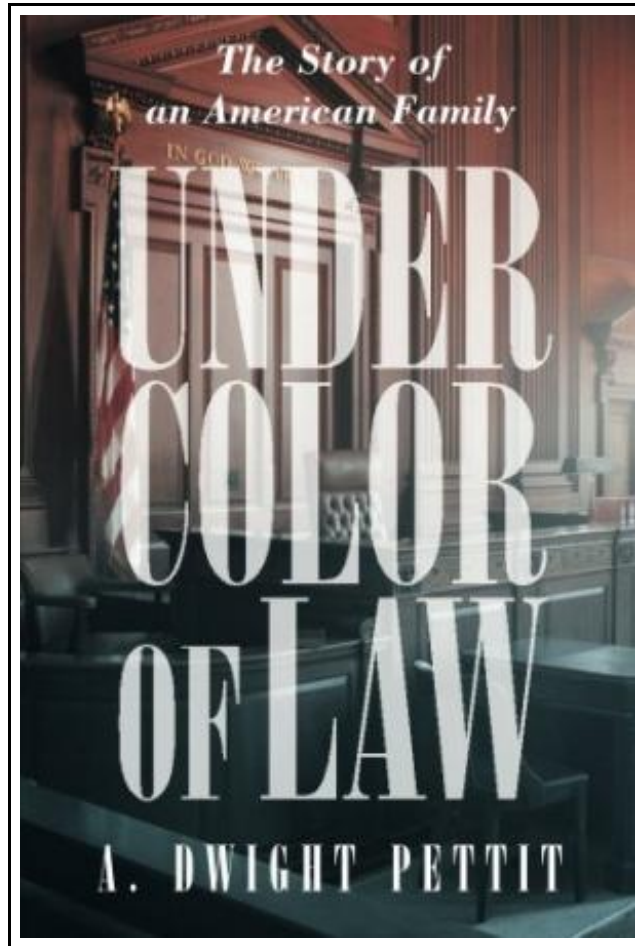

He recalls his time at Howard University as well as the major litigation and representation in which he was involved as a lawyer, focusing in particular on his father s case which involved the treatment, torment and retaliation his father experienced at his job for bringing his son s desegregation lawsuit to trial. Attorney Pettit s memoir also traces his involvement in politics, especially his intimate role in the Jimmy Carter 1976 presidential campaign and the Carter administration. Providing insight into past and current civil-rights issues, Under Color of Law underscores the Pettit family s pursuit of justice in the context of the drive for equal rights for all.
